



VETFEST 2025 VENDOR AGREEMENT

THIS AGREEMENT made and entered into the _____ day of _____ 2025 by and between: Got Your Six, LA represented herein by a duly authorized Representative of VETFEST, Timothy Sloan hereinafter referred to as the FIRST PARTY, and _____, represented by _____, whose mailing address is _____, and whose phone number is _____, and email is _____, and whose LA Tax ID # if applicable is _____ hereinafter referred to as the SECOND PARTY.

WHEREBY it is agreed:

- 1. FIRST PARTY has engaged SECOND PARTY to operate an Informational, Philanthropic, or retail booth November 08, 2025, at the VETFEST, located at the event pavilion across the street from the Bossier Arts Council at 501 Barksdale Blvd, Bossier City, LA, 71111

Hours of Operation: Saturday 11/08/2025 11 am to 5 pm

Public interaction may occur only in designated assigned vendor area. Any handouts must be approved in advance by FIRST PARTY. Booth must be kept clean during the entire VETFEST and must be operated for the full morning/afternoon event. All signage must be approved by FIRST PARTY in advance.

- 2. In consideration of the above activities, FIRST PARTY is responsible for providing all necessary items such as tables, pop up tent cover and chairs. Any signs or volunteers needed to provide the service or activity are the responsibility of the SECOND PARTY.
- 3. SECOND PARTY agrees to adhere to current COVID requirements as set forth by Governor of Louisiana during their participation.
- 4. For vendors in consideration to participate in the VETFEST, SECOND PARTY agrees to donate an amount dependent on their qualifying category, please circle below:
 - a. For Profit, Veteran owned SECOND PARTY wishing to participate agrees to donate \$50 to FIRST PARTY
 - b. For Profit, Non-Veteran owned SECOND PARTY wishing to participate agrees to donate \$100 to FIRST PARTY
 - c. Non-Profit SECOND PARTY wishing to participate will not be asked for a donation to FIRST PARTY
- 5. SECOND PARTY's participation in the event shall be subject to general rules as FIRST PARTY may, from time to time, prescribe in its sole discretion governing the use of the premises. This document contains the entire agreement between the parties and cannot be changed or supplemented except by written agreement signed by both parties.
- 6. If presentation of the VETFEST should be prevented by governmental action, strike, riot, act of God or other cause beyond the control of the FIRST PARTY, parties agree that this contract shall be without effect and that there shall be no liability on the part of the FIRST PARTY to the SECOND PARTY.
